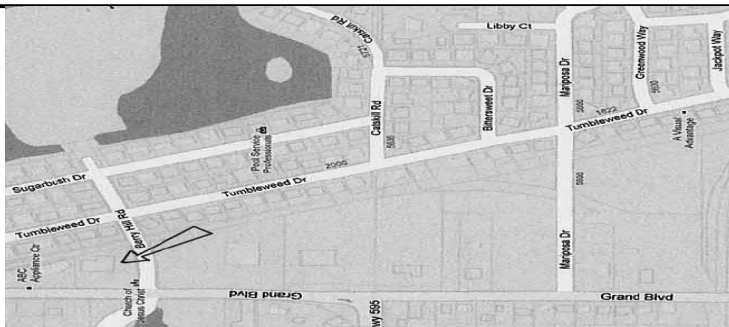


President's Message:

DEED RESTRICTIONS

Bill and Stan, who handle Deed Restriction Violations always:

1. First, talk to the Homeowner to explain the violation, and give a copy of the FHE Deed Restrictions. They ask Homeowners to request permission for any temporary needs. (This face-to-face contact can happen several times in an effort to reconcile the violation.)
2. Second, notify the Homeowner in writing (sometimes this is the only way to contact the homeowner), with ample time to call or correct the problem.
3. When all efforts fail, the violation becomes Pasco County Code's problem. They also give a warning. If the warning is ignored, and the Homeowners fail to comply, Pasco County can and will issue a fine.

***We are neighbors, with the best interest of
the Community at heart, so there is no reason
any violations cannot be reconciled. Do not
ignore violation notices—comply. If for some
reason you can't, contact Bill or Stan. Don't let
a community problem become a Pasco County***

problem.

Please Remember: Do not block the sidewalk. This is a danger to all residents—children to Seniors, as they are forced to walk, bike, or use wheelchairs/scooters in the street. This is a serious Pasco County Code violation, subject to Pasco County jurisdiction and fines. More importantly, we are putting our children and neighbors at risk.

When you walk your dog/dogs, be sure to pick up their waste. It is the responsible thing to do as a pet owner and neighbor. Also, leaving waste on the ground, street, or walk, adds to the pollution of our water.

Pasco County Agencies:

Although we at FHECA are willing to help all our members, many issues must be resolved by the Pasco County Sheriff's office or other Pasco County agencies.

Remember:

1. NO LONG DURATION STREET PARKING is a posted County ordinance and a hazard to traffic within the subdivision.
2. Pasco County Noise Ordinance mandates "Quiet Time" - 10pm to 7am everyday. ***This includes loud car radio and engine noises—deliberately revving your engine as you enter or leave. Please be more considerate of your neighbors and their eardrums!***
3. Please contact Board Members between the hours of 9 am—5 pm, Mon-Thurs, unless it is an emergency.
4. Never post or hang signs or posters on any street signs—it is forbidden by Pasco County Ordinance.

RECYCLING:

Paper can now be recycled with plastic, aluminum cans, and clear, green, or brown glass using your designated container.

To recycle all the used batteries take them to our local library on Mile Stretch.

Paper —Newspaper, Boxes , broken down flat, Envelopes, Any clean paper may also be taken to:

- 1. Pasco Schools have recycle bins that earn revenue for the schools. (Nearest to FHE— Sunray Elementary next to Publix on Sun-ray).*
- 2. Other County recycle bins earn revenue for Libraries, parks, and fire stations. (Nearest to FHE — South Holiday Library on Mile Stretch, bin located in back of Library.)*

If you are unable to take your papers to a Recycle bin, call Millie Olsen 727-943-0939 or 727-389-0033 (leave message) and pick up will be arranged. You can also leave your paper to be recycled on Millie's front porch at 5629 Ivy Lane in FHE or bring it to the meeting.

Note: Plastic grocery bags can be recycled at your grocery store or Wal-Mart.

Recipe of the Month:

This is a great soup —easy to make, serve with a salad and bread for a great cool weather lunch or dinner.

Shrimp and Cream Cheese Soup

- 1 package** Philadelphia Cream Cheese (8 ounce size)
- 1/2 cup** sweet cream butter
- 1 cup** chopped green onion tops
- 2 cans** Campbell's Cream of Potato Soup (10 ounce size)
- 1 can** whole kernel or shoepeg corn (15 ounce size)
- 1 can** cream style corn (15 ounce size)
- 2 cups** whole milk
- 1 lb.** cooked cocktail shrimp, peeled and de-veined
- 1 tsp.** Frank Davis Seafood Seasoning or Old Bay Seasoning (not so spicy)

In a heavy 5-quart soup pot, slowly melt the cream cheese and the butter over low heat.

Then add the green onions and gently simmer them for about 10 to 12 minutes.

Next, stir in the potato soup and both cans of corn and continue the simmering process for an additional 15 minutes.

Then, begin stirring in the milk in order to reach the desired consistency-start off with half a cup, then add more if necessary.

At this point the soup should be nice and thick, having the texture of light pancake batter.

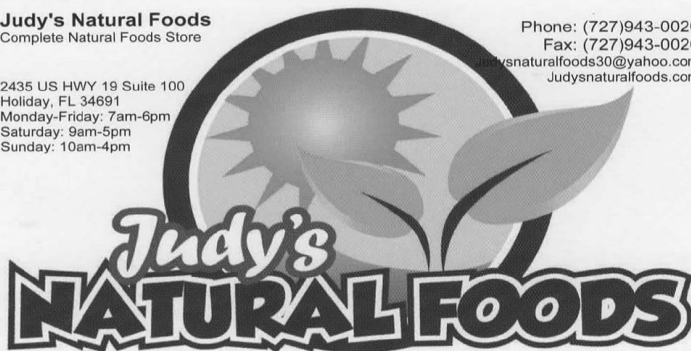
Finally, just before you're ready to eat, fold in the shrimp, stir in the seafood seasoning, and heat the pot to hot and bubbly.

PS. You can use a one cup of half and half and one cup of milk, if you prefer, rather than 2 cups of milk, especially if you are using 1% milk.

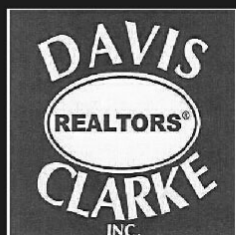
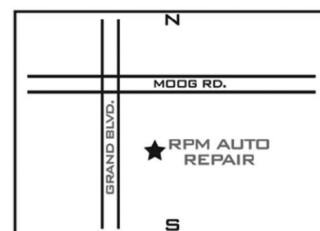
