President's Message: *Meeting Speaker: Capt. Stephen Hartnett—Sheriff's Office*

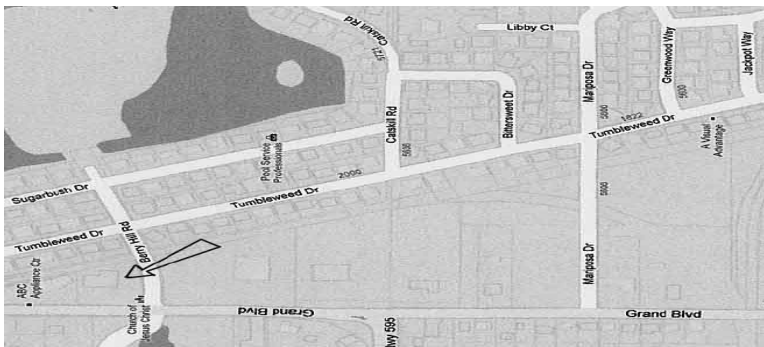

DEED RESTRICTIONS

Reminder: Dogs must be on a leash when not behind a fence. Dogs cannot be loose in the Subdivision. This is Pasco County ordinance too. Even though your pet may appear harmless to you, you can be scaring others – especially children and the elderly. Even playing, a child or elderly person can be knocked down as well as scared by your pet. Be a good “pack leader” for your pet, and keep him safe behind a fence or on a leash.

Sidewalks: I know many of you have had relatives and friends visiting for the Holidays. Please remember: **Do not block the sidewalk.** This is a danger to all residents—children to Seniors, as they are ~~forced to walk, bike, or use wheelchairs/~~

scooters in the street. This is a serious Pasco County Code violation, subject to Pasco County jurisdiction and fines. More importantly, we are putting our children and neighbors at risk.

When you walk your dog/dogs, be sure to pick up their waste. It is the responsible thing to do as a pet owner and neighbor. Also, leaving waste on the ground, street, or walk, adds to the pollution of our water.

1. NO LONG DURATION STREET PARKING is a

posted County ordinance and a hazard to traffic within the subdivision.

2. Pasco County Noise Ordinance mandates "Quiet Time" - 10pm to 7am everyday. ***This includes loud car radio and engine noises—deliberately revving your engine as you enter or leave. Please be more considerate of your neighbors and their ear-drums!***
3. Please contact Board Members between the hours of 9 am—5 pm, Mon-Thurs, unless it is an emergency.
4. Never post or hang signs or posters on any street signs—it is forbidden by Pasco County Ordinance.

RECYCLING:

Paper can now be recycled with plastic, aluminum cans, and clear, green, or brown glass using your designated container.

To recycle all the used batteries take them to our local library on Mile Stretch.

Paper—Newspaper, Boxes, broken down flat, Envelopes, Any clean paper may also be taken to:

1. Pasco Schools have recycle bins that earn revenue for the schools. **(Nearest to FHE—Sunray Elementary next to Publix on Sunray).**
2. Other County recycle bins earn revenue for Libraries, parks, and fire stations. **(Nearest to**

FHE — South Holiday Library on Mile Stretch, bin located in back of Library.)

Recipe of the Month:

This simple recipe for Potato Soup is from Hazel Hale Bostic, a high school friend & writer from Virginia. It is actually her Mother's recipe, so it has stood the test of time.

Hale's Potato Soup

5-6 Medium, peeled and quartered Potatoes

1 Large diced onion

1/2 cup diced celery (optional)

1 1/2 teaspoons salt or to taste

1/2 teaspoon pepper

1/2 cup butter or margarine

Place all in a 4-quart pot and cover with water To about 1/2 inch above the vegetables.

Simmer until tender. When done, mix

1/3 cup of flour and 1 cup of canned

Cream until smooth. Pour in pot of Vegetables and stir until thickened.

Delicious with hot cornbread (or French bread, or any bread)

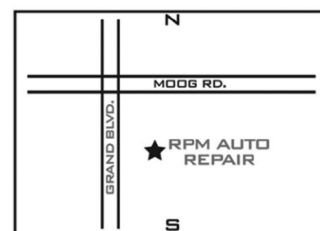

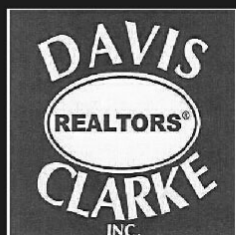
