Standing committees:

1. **Audit:** The Audit Committee shall audit the books and all financial records of the Association.
2. **Community Appearance Board (CAB):** To preserve the architectural and aesthetic appearance of the properties in Forest Hills East in accordance with the appropriate CAB Articles as stated in the FHECA By-Laws and Deed Restrictions.
3. **Membership:** coordinating the receipt of membership monies with the Treasurer
4. **Public Relations:** Promoting Forest Hills East as a safe, pleasant community in social media and other platforms that meet these goals.
5. **Rules and By-Laws:** Review the FHECA By-Laws and Deed Restrictions to meet the needs of the FHECA members and submit suggestions to the Board for consideration.
6. **Social:** shall prepare a schedule of planned social events and submit same to the Board of Directors for approval.

Special Committee shall be:

1. **Nominating Committee:** Nominations for all elective offices must be submitted to the FHECA Secretary by the Nominating Committee at least one week prior to the November meeting. The Chairperson who conducts the November meeting must also call for nominations from the floor. Nominations will be closed by a majority vote of the members present at any time during the November meeting. Nominations will be held at the November meeting, elections in December and seating of officers and directors in January of the following year.

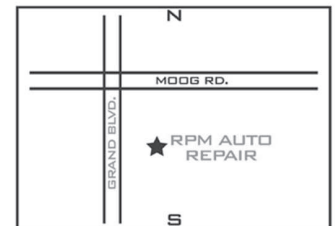

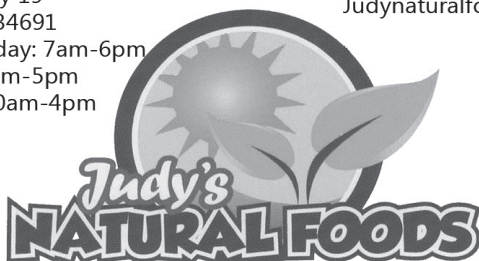
