



#### DEED RESTRICTIONS

Bill and Stan, who handle Deed Restriction Violations always:

1. First, talk to the Homeowner to explain the violation, and give a copy of the FHE Deed Restrictions. They ask Homeowners to request permission for any temporary needs. (This faceto-face contact can happen several times in an effort to reconcile the violation.)

2. Second, notify the Homeowner in writing (sometimes this is the only way to contact the homeowner), with ample time to call or correct the problem.

3. When all efforts fail, the violation becomes Pasco County Code's problem. They also give a warning. If the warning is ignored, and the Homeowners fail to comply, Pasco County can and will issue a fine.

We are neighbors, with the best interest of the Community at heart, so there is no reason any violations cannot be reconciled. Do not ignore violation notices—comply. If for some reason you can't, contact Bill or Stan. Don't let a community problem become a Pasco County problem.

Please Remember: <u>Do not block the</u> <u>sidewalk.</u> This is a danger to all residents-children to Seniors, as they are forced to walk, bike, or use wheelchairs/ scooters in the street. This is a serious Pasco County Code violation, subject to Pasco County jurisdiction and fines.

When you walk your dog/dogs, be sure to pick up their waste. It is the responsible thing to do as a pet owner and neighbor. Also, leaving waste on the ground, street, or walk, adds to the pollution of our water.

### **Recipe of the Month:**

Thanks to Cheryl for this easy fritter recipe, perfect for this time of year. Best of all, you probably have all the ingredients on hand!

Easy Homemade Apple Fritters

cup all purpose flour
1/4 cup sugar
3/4 teaspoon salt
1/2 teaspoons baking power
teaspoon cinnamon
1/3 cup milk
egg
cup chopped apple

Glaze:

- 2 cups powdered sugar
- 1 1/2 tablespoons milk

Combine flour, sugar, salt, baking powder, cinnamon. Stir in milk and egg until just combined. Fold in apple. Pour oil into skillet so that it is approximately 1 1/2 inches deep. Heat oil on high. Oil is ready when a little dough thrown in floats to top. Carefully add dough to oil in heaping teaspoons. Cook until brown, about 2 minutes, then flip. Cook another 1-2 minutes, until both sides are browned. Transfer briefly to paper trowels to absorb excess oil, then transfer to cooling rack. Make glaze by stirring milk and powered sugar together in a small bowl. Drizzle over apple fritters. Wait approximately 3 minutes for glaze to harden, then flip fritters and drizzle glaze over the other side. Best served warm.

Easy & tastes good, even without the glaze. ( It took only one medium apple. )
